
### EIT Urban Mobility Call Programme 2025

### Student Entrepreneur Grant Scheme

Long-term open call BP 2023-2025

#### Type of activities

This grant is to support students/recent graduates in developing their projects/ideas into a new startup venture. By providing small financial grants, we aim to help students to overcome the first significant barrier in turning their ideas into reality. The programme is aimed at nurturing the entrepreneurial spirit and fostering a culture of innovation among students.

#### Type of applicants

Applicants need to be part of a team with at least two members. The team members can be from any nationality, but the project leader should be residing in one of the Member States of the European Union, and/or in a third country associated with Horizon Europe at the time of submission of the application. At least one team member should be enrolled in/graduated from an EIT-labelled programme under EIT Urban Mobility.

### Accelerator Programmes/Mobility Corporate Ventures Builder Open Call 2026

Open call BP 2026-2028 ①

#### Type of activities

This open call consists of two different tracks: Accelerator Programmes and a Mobility Corporate Venture Builder. The Accelerator Programmes track provides support for innovative mobility solutions by nurturing startups. The Accelerator Programmes offered to startups includes their participation in living labs and business coaching, as well as urban mobility-specific expertise such as technology or market validation, product-market fit or market entry. EIT Urban Mobility aims to use 50% of the total budget to co-fund a maximum of two Accelerator Programmes, with one cohort of startups supported in each programme.

The Mobility Corporate Venture Builder track fills the missing gap at the initial point of the entrepreneurship journey by developing a venture model that systematically produces new mobility companies, addressing innovation problems that corporations face. EIT Urban Mobility aims to invest in one Mobility Corporate Venture Builder that is focusing on priority topics in order to become an industry trend-setter.

# Regional Innovation Scheme (RIS) Joint Innovation Programme with ADRVest in Romania Open Call

Open call BP 2023-2025

#### Type of activities

This call is a collaboration with the Romanian Development Agency for the Western Region. It is expected to support the development of high-potential innovative RIS urban mobility startups or startups getting active in the Romanian Region West market. The selected implementing body must design a support programme with two distinct paths: a venture-building track for innovative ideas aiming to register as a business in Romania and a startup track for established companies willing to register a subsidiary in Romania to expand operations in the region. The programme should include the following stages regardless of the path: scouting phase/recruitment phase/support phase/demo day.

#### Type of applicants

Legal entities established in the Member States of the European Union, and/or in third countries associated to Horizon Europe. The call is strategically focused on identifying a suitable partner for the development of urban mobility-related innovations, with a specific emphasis on the Romanian Region West market.
